### Correction to FY23 Appendix 4G and Corporate Governance Statement

**Mad Paws Holdings Limited** (ASX:MPA) (“**Mad Paws**” or the “**Company**”), refers to its Appendix 4G and Corporate Governance Statement for period ended 30 June 2023, which was released to the ASX on 29 August 2023. The Appendix 4G inadvertently contained errors which have been rectified in the revised version attached herewith.

The errors identified were as follows:

1. Section 5.1 of Appendix 4G lacked a link to the Company's website.
2. References to the FY23 Annual Report in Sections 7.2 and 8.2 of the Appendix 4G lacked accompanying page numbers on which the relevant information is contained.
3. Section 7.1 of Appendix 4G two boxes in the form were ticked by error.

We have rectified these errors in the revised Appendix 4G, which is attached to this announcement. All other information in Appendix 4G remains unchanged.

The FY23 Corporate Governance Statement, however, remains unaltered. For reference purposes, it has been included with this announcement.
